Call to Order

The Regular Meeting of the Board of Commissioners of Public Hospital District No. 2, Snohomish County, was called

to order at 8:00 a.m. by President Knowles.

Executive Committee

President Knowles reported that the Executive Committee met on June 18, 2014 to review and approve the June 25,

2014 board meeting agenda. No action was taken. President Knowles announced that there will be no Executive Session in this board meeting as there are no

items for discussion.

Board Finance Committee The committee met on June 18, 2014. Ms. King reviewed the financial statements and cash activity for May 2014 (E:31:14).

Authorization for Payment of Vouchers & Payroll Warrant Numbers 10678 through 10713 for May 2014 for payment in the amount of \$169,643.95 were presented for approval (E:32:14). *Motion was made, seconded and passed unanimously to approve.*

Program Oversight Committee Update The Program Oversight Committee met on June 9, 2014 to review four new program funding applications, follow-up on the Puget Sound Kidney Center request, and review a request from the Swedish/Edmonds Foundation (E:33:14 & E:34:14).

One conflict of interest was reported by Commissioner Langer on the brain injury support group proposal. He recused himself from the discussion.

New Funding Applications:

Motion was made, seconded and passed unanimously to approve \$180,000 on a one-time basis for the Medical Teams International Mobile Dental Vehicle purchase. The board would like the funding agreement to protect Verdant if MTI ever sold or disposed of the vehicle.

Motion was made, seconded and passed unanimously to approve \$33,000 for one year for WithinReach South Snohomish County Insurance Corps request to support outreach and education on the Affordable Care Act.

Motion was made, seconded and passed with Commissioner Langer abstaining to approve \$3,500 for one year for the Brain Energy Support Team's Edmonds Head Injury Support Group hosted at Swedish/Edmonds Hospital. Commissioner Williams suggested the Superintendent's Discretionary Fund could be used for this program.

Not Recommended for Funding:

The committee is not recommending funding for the Guided Pathways Support for Youth & Families family support program in the hospital district.

Follow-up on Previous Application:

Motion was made, seconded and passed unanimously to approve \$120,000 for two years for the Puget Sound Kidney Center Foundation's Chronic Kidney Disease Education and Prevention Program. This revised request is for \$70,000 in

year 1, \$50,000 in year 2 and an increase from 50 to 100 patients served per year.

Kindering South Snohomish County Expansion: Kindering attended the Program Committee meeting on June 9, 2014 to review the proposal in detail. The committee would like to see more of an integrated program where service providers are collaborating to best serve local families.

The commissioners discussed the request from Swedish/Edmonds Foundation (E:35:14) for \$50,000 in support of the new ambulatory care center. Commissioner Wilson identified several follow-up questions and the board discussed several naming opportunities. No action taken and the full board would like to hear directly from a Swedish/Edmonds Foundation leader on the use of the funds. Mr. Kosovich will coordinate a meeting.

Marketing Report

Ms. Piplic presented the Marketing Report (E:36:14) including an update on 6 Weeks to a Healthier You 2014 and The Canopy newsletter issue coming in late June. The reunion session for 6 Weeks will be held on October 28, 2014 at the Lynnwood Convention Center along with another round of biometric screenings. Participants from 2012, 2013 and 2014 will be invited to this session. Looking ahead to 2015, Verdant will focus on programming in the Verdant Community Wellness Center and will therefore not continue with another round of 6 Weeks to a Healthier You in Spring 2015, although it may be explored again at a future date.

Commissioner Comments

Commissioner Williams shared an article from the Seattle Times on hospital-acquired infections that are charged and reported to Medicare. Swedish/Edmonds ranked among the top six hospitals (E:37:14).

Commissioner Knutsen shared about an online program through the University of Washington as a possible program for the Verdant Community Wellness Center.

Superintendent's Report

Superintendent Zapora is attending the WSHA conference in Lake Chelan. Mr. Kosovich reported on two items:

- 1. Superintendent Zapora is presenting on a panel at the WSHA conference on Verdant's programs.
- 2. Board mini retreat is on Friday, June 27, 2014, 12 p.m. at the Lynnwood Convention Center. An in-depth look at Verdant's programs will be done.

Public Comments Mr. Al Rutledge commented on the increase in population in the district and its effect on urgent care clinics, where the hospital will be in five years, and why are doctors leaving the hospital.

Mr. Dick Frederick of Medical Teams International commented that he is impressed with the board members and the meeting procedure. He also thanked the board for the \$180,000 for the dental van and that 1,600 people per year will receive treatments from this van. Mr. Frederick also wanted the board to know that of the \$360,000 cost for the van, up to \$180,000 is coming from WDS, \$10,000 from the Nysether Family Foundation, and a possible \$50,000 from Cambia.

There being no further business to discuss, the meeting was adjourned at 8:42 a.m.

Verdant received dividends payments of \$28,131 and an unrealized gain of \$46,592 on our investment portfolio in May for an ending market value of \$29,680,578.

Annual program commitments total \$5,180,566 and \$4,215,878 for 2014 and 2015, respectively. \$1,569,434 remains available to spend in 2014, of which \$230,500 is earmarked as Superintendent Discretionary.

Additional income of \$103,641 and expenses of \$33,835 from the Kruger Clinic were incurred, netting to an additional operating income of \$69,806 in May.

Program Summary

Recommended for Funding

• Medical Teams International – Mobile Dental Vehicle: A one-time request of \$180,000 to purchase a mobile dental clinic vehicle to replace a vehicle that was recently retired. The clinic will be used to provide 72 dental clinics in Verdant's district each year serving a total of 720 patients. Verdant is being asked to fund 50% of the vehicle purchase price, and Washington Dental Services Foundation has committed to fund the rest.

The program committee is recommending fully funding the request at \$180,000 on a one-time basis. Pages 18-19 of this packet have additional information on the vehicle and anticipated clinics.

• Within Reach – South Snohomish County Insurance Corps: A one-year renewal request to support outreach and education on the Affordable Care Act. The program would include in-person education, eligibility screening, application assistance and follow-up. Funds would be used for a bilingual Russian/Ukrainian outreach worker and one Americorps outreach worker stipend. Verdant previously provided \$50,000 in funding for the program, and Within Reach exceeded its goal for enrollments. The program would expect to educate 1,600 families and enroll at least 400 families in health insurance.

The program committee is recommending fully funding the request at \$33,000 for one-year.

Brain Energy Support Team - Edmonds Head Injury Support Group: A one-time request to support the
Edmonds Head Injury Support Group hosted at Swedish/Edmonds Hospital with the Brain Injury Support
Team acting as the fiscal sponsor. Verdant funds would be spent on community events, speakers, materials
and other support group costs. Commissioner Langer recused himself from the discussion of this proposal.
The program committee is recommending fully funding the request at \$3,500 for one-year.

Not Recommended for Funding

• Guided Pathways – Support for Youth & Families: Guided Pathways is a family support organization based in Kent that was founded in 2012. The organization is requesting funding to launch a family support program in Verdant's district and create "resource centers" in churches libraries, and other places where families could receive support. Verdant funds would be used for 1 FTE Family Advocate and 1 FTE Peer support specialist.

The program committee is not recommending funding the program at this time. The committee was concerned that this would be a large grant to a new agency that would have to establish itself in South Snohomish County.

Follow-up on Previous Applications

Puget Sound Kidney Center (PSKC) Foundation – Chronic Kidney Disease Education and Prevention
 Program: a revised request for a new program focused on helping to reduce the progression of kidney disease. The request would fund 1.1 FTE positions for a program manager, social worker, dietician, and a nurse.

After further discussion, the program committee is recommending funding the program for two years for a total of \$120,000. The committee reviewed some additional information on cost (included on page 20) and PSKC has committed to increasing the number of patients served to 100 per year.

• Kindering - South Snohomish County Expansion: a request for \$135,985 per year for three years to serve children with developmental delays. The program committee met with the applicant and reviewed the program in more detail. Following the discussion there are still some concerns about how the services fit in with existing service providers like Wonderland and ChildStrive in South Snohomish County.

The committee would like to see more of an integrated program where service providers are collaborating to best serve local families. Commissioner Langer is also interested in visiting the organization's Bothell facility.

Details of Clinic Projections

The chart below shows the current number and location of Mobile Dental clinics in Verdant's service area, Snohomish County Hospital District No. 2. It also shows our plan to increase the number of clinics in this area from our current 48 per year to 72 per year. If we secure funding for the new van by July 2014, we anticipate launching it into service by Spring 2015. The addition of monthly clinics with a new site partner will coincide with this launch, bringing us to 72 clinics per year.

MTI can commit to holding up to 72 clinics in the Verdant geographical area given the following:


- Verdant funds half the remaining cost of the Mobile Dental van (\$180,000). The targeted number of clinics we will hold in Verdant's district will be proportional to the amount of the van cost that Verdant contributes.
- MTI can continue to apply for and receive <u>operational</u> funding grants for the targeted number of clinics up to this maximum (72).
- Each 3-year grant cycle includes an assessment and confirmation that sufficient dental need and barriers to access remain to continue funding at the existing level.
- MTI is able to access Verdant's network of community partners for the purpose of developing additional site partners.
- MTI will provide Verdant with Letters of Intent from existing and future partners to confirm the clinic commitments outlined in the chart above.

Additional Benefits for Verdant of Funding the New Van

Verdant will receive the following benefits as a result of funding the new van:

- In addition to the commitment of 72 clinics per year discussed above, MTI agrees to hold a
 quarterly clinic organized by Verdant in Snohomish County Hospital District No. 2 which will be
 funded through outside sources. This additional quarterly clinic will continue through the
 remainder of the current operational funding agreement, and will be reassessed with each new
 operating agreement.
- Verdant will have a logo prominently placed on one side of the new Mobile Dental van. The Verdant logo will be in *Graphics Area A*, an area which is approximately 72 inches wide and 36 inches high and considered prime placement for donor logos. The sponsor logo space is located on the front middle third of the van on both sides. The size of the logo will depend on the number of donors and the percentage of the total van cost contributed by each. The logo areas include a heading that reads, "Made possible by generous grants from." In the case of a funding split between Verdant and WDS Foundation, each would receive a logo on one side in Area A. This logo will remain for the life of the van. If at any time either party is the subject of public disrepute or scandal, the other party shall have the right to request removal of the logo from the van.
- The inherent mobility of the Mobile Dental van will help to expand awareness of Verdant and the benefits they are bringing to the south Snohomish County community as the van travels to multiple locations throughout Verdant's district.

Some of the best-known hospitals in the Puget Sound area may face penalties under the government's toughest effort yet to crack down on infections and other patient injuries, federal records show.

In Seattle, Swedish Medical Center hospitals on First Hill and Cherry Hill and UW Medicine's Harborview Medical Center and Northwest Hospital could have their Medicare payments docked this fall, based on a suite of patient-safety measures.

A quarter of the nation's hospitals — those with the worst rates — will lose 1 percent of every Medicare payment for a year starting in October.

In April, federal officials released a preliminary analysis of hospitals on track to be penalized, including 14 out of 48 hospitals in Washington state. Nationwide, 761 face sanctions, though the list could change because the government will be looking at performance over a longer period than it used to calculate the draft penalties.

In King County, the four Seattle hospitals plus MultiCare Auburn Medical Center were just slightly above the penalty cutoff, while eight others in the county scored better. No hospitals in Pierce or Snohomish counties were pegged for sanctions.

"We're constantly challenging ourselves to improve, regardless of how we were already doing," said Dr. Rick Goss, medical director of Harborview and director of Quality of Metrics Reporting for UW Medicine.

The sanctions, estimated to total \$330 million nationwide, kick in at a time when many hospital infections are on the decline, but still too common.

In 2012, 1 of every 8 patients nationally suffered a potentially avoidable complication during a hospital stay, the government estimates. Even infections that are waning are not decreasing fast enough to meet government targets. Meanwhile, new strains of antibiotic-resistant bacteria are making infections much harder to cure.

ne medical profession has not covered itself with glory in terms of medical errors and events that should not occur," said Dr. Terry Rogers, chief executive officer for the Seattle-based Foundation for Health Care Quality, a nonprofit organization. "We have chipped around the edges, but we still kill a lot of people in hospitals who should not die."

Are the metrics right?

Medicare's penalties are going to hit some types of hospitals harder than others, according to an analysis of preliminary penalties conducted for Kaiser Health News by Dr. Ashish Jha, a professor at the Harvard nool of Public Health.

Publicly owned hospitals and those that treat many low-income patients are more likely to be assessed penalties. So are large hospitals, ones in cities, and those in the West and Northeast. Preliminary penalties were assigned to more than a third of hospitals in Alaska, Colorado, Connecticut, the District of Columbia, Nevada, Oregon, Utah, Wisconsin and Wyoming.

The biggest impact may be on the nation's major teaching hospitals: Slightly more than half were marked for preliminary penalties, Jha found. The reasons for such high rates of complications in these elite hospitals are being intensely debated.

Harborview, a teaching hospital, is the state's only Level 1 trauma center and treats patients with severe injuries and burns from a four-state area. Given that status, these patients "will be more susceptible to some of the hospital-acquired conditions," Goss said. The University of Washington Medical Center does not face penalties.

Leah Binder, CEO of The Leapfrog Group, a patient-safety organization, said academic medical centers have such a diverse mix of specialists and competing priorities of research and training residents that safety is not always at the forefront.

When calculating infection rates, the government takes into account the size of the hospital, the location where the patient was treated and whether it is affiliated with a medical school. But the Association of American Medical Colleges and some experts question whether those measures are precise enough.

"Do we really believe that large academic medical centers are providing such drastically worse care, or is it that we just haven't gotten our metrics right?" Jha said. "I suspect it's the latter."

In addition, there may be little difference in the performance between hospitals that narrowly draw federal penalties and those that barely escape them. That is because the health law requires Medicare to punish the worst-performing quarter of the nation's hospitals each year, even if they have been improving.

MultiCare Auburn Medical Center has been working to improve patient care since it was acquired by MultiCare Health System in late 2012, spokeswoman Marce Edwards said in an email. That meant bringing the organization's safety program to the new location and standardizing processes at the hospital.

Providers with UW Medicine are likewise working to standardize many procedures across their facilities to make sure they're all using the best approaches to reduce infections and injury, and they meet on a monthly basis to share their results.

"There is still room for improvement," Goss said. "In all cases we try to eliminate the variation and look for any reason why one patient didn't receive all of the care that was intended."

Pay for performance

The Hospital-Acquired Condition (HAC) Reduction Program, created by the Affordable Care Act, is the third of the federal health law's major mandatory pay-for-performance programs. The first levies penalties against hospitals with high readmission rates and the second awards bonuses or penalties based on two dozen quality measures. Both are in their second year.

When all three programs are in place this fall, hospitals will be at risk of losing up to 5.4 percent of their Medicare payments.

the first year of the HAC penalties, Medicare will look at three measures. One is the frequency of odstream infections in patients with catheters inserted into a vein to deliver antibiotics, nutrients, chemotherapy or other treatments. The second is the rates of infections from catheters inserted into the bladder to drain urine. Both those assessments will be based on infections during 2012 and 2013.

Finally, Medicare will examine a variety of avoidable safety problems in patients that occurred from July 2011 through June 2013, including bedsores, hip fractures, blood clots and accidental lung punctures.

Over the next few years, Medicare will also factor in surgical-site infections and infection rates from two ms that are resistant to antibiotic treatments: Clostridium difficile, known as C. diff, and Methicillinsistant Staphylococcus aureus, known as MRSA.

Nationally, rates of some infections are decreasing. Catheter-related infections, for instance, dropped 44 percent between 2008 and 2012. Still, the Centers for Disease Control and Prevention estimates that in 2011, about 648,000 patients — 1 in 25 — picked up an infection while in the hospital, and 75,000 died.

Rates of urinary-tract infections have not dropped despite efforts. These infections become more likely the longer a line is left in, but sometimes they are not removed promptly — out of convenience for the nurse or patient or simply institutional lethargy.

Swedish Medical Center on First Hill beats many U.S. hospitals when it comes to central-line associated bloodstream injections, but has higher urinary-catheter infection rates than others. To help correct that, Swedish has given nurses more authority to remove catheters instead of waiting for a physician's order to remove it, said Dr. Michael Myint, Swedish's vice president for quality and patient safety.

Additionally, their protocols have turned around the decision-making about catheters, said Myint, so "unless you have a clinical reason to keep the catheters in, they should come out."

About four years ago, Swedish launched a renewed focus on safety, he said, calling on everyone from the window washers to the top surgeons to make patient safety a priority. The goal is to reduce the incidence of preventable harm to zero, Myint said. "We're going to be relentless until we get there."
