Call to Order

The Regular Meeting of the Board of Commissioners of Public Hospital District No. 2, Snohomish County, was called to order at 8:00 a.m. by President Langer.

Approval of Minutes

Motion was made, seconded and passed unanimously to approve the minutes of the regular meeting on

November 16, 2016.

Motion was made, seconded and passed unanimously to approve the minutes of the special board meeting on December 2 to 3, 2016.

Executive Committee

Commissioner Knutsen reported that the Executive Committee met on December 9, 2016 to review the December 14, 2016 board meeting agenda, discuss the recent board special meeting/retreat goals and

strategic plan, and spend time with the new Superintendent.

Motion was made, seconded and passed unanimously to approve the 2017 meeting schedule (E:77:16). 2017 proposed officers and committee assignments were presented (E:78:16) and will be approved at the January 25, 2017 regular board meeting.

Superintendent Appointment

Motion was made, seconded and passed unanimously to approve Resolution 2016:09 appointing Dr. Robin Fenn as Superintendent of the district and removing Carl Zapora as Superintendent of the district as of December 31, 2016, 3 p.m.

Board Finance Committee

The committee met on December 12, 2016. Ms. King reviewed the financial statements and cash activity for November 2016 (E:79:16). Warrants called out include #11964 to Foster Pepper for \$24,901.40, and #11972 to K & K Construction for painting at the Kruger Clinic which was paid from Verdant due to the change in the Kruger Clinic property management firm. Deposits called out include \$148,547.00 for 2008 CPE Medicare settlement, \$842,988.86 for M & O levy payment, and \$1,000.00 from a sponsorship of the Verdant Healthier Community Conference in 2017.

Authorization for Payment of Vouchers & Payroll

Warrant numbers 11929 through 11985 for November 2016 for payment in the amount of \$97,005.41 were presented for approval (E:80:16). *Motion was made, seconded and passed unanimously to approve.*Warrant numbers 11877 through 11928 for October 2016 for payment in the corrected amount of \$123,872.84 were also presented for approval (E:81:16). *Motion was made, seconded and passed unanimously to approve.*

Commissioners Knutsen and Knowles thanked Ms. King for her good work.

Ankrom Moisan Feasibility Study

Ankrom Moisan & Mortenson Construction presented a feasibility to the board with potential options for developing the Value Village parcel in to something that aligns with Verdant's mission, vision and strategic plan and is also a potential investment opportunity (E:82:16).

Commissioner Williams commented that there are several potential needs for that parcel. Beyond mental health, he was interested in cancer treatment, infusion space, geriatric care, primary care and retail or educational space. He wants to maintain a positive frontage to the hospital.

Commissioner Wilson commented that the PHD has the option to continue to sign short-term leases with Value Village or leave the building unoccupied so there is no need to rush a decision based on the lease expiration. President Langer thanked Ankrom Moisan & Mortenson Construction for the study and commissioners agreed that a future study session(s) to further explore options for the parcel will occur in early 2017.

No conflicts of interest were reported by any of the commissioners present.

The Program Committee met on December 9, 2016 to review four applications for renewal funding (E:83:16).

Program Applications Recommended for Funding: Motion was made, seconded and passed unanimously to approve the Senior Services of Snohomish County Care Coordination Program in the amount of \$135,000 for one year as alternative funding models emerge. Commissioner Williams asked that the board be notified if one year of funding created challenges for Senior Services.

Program Applications Not Recommended for Funding: Alpha Supported Living Services Wellness Program for Individuals with Disabilities as providing nursing services for residents does not connect closely enough with a Verdant funding priority.

Program Applications for Additional Discussion:

Northwest Parkinson's Foundation South Snohomish County Programming – Commissioner Williams voiced a conflict for himself as he has patients with Parkinson's. Motion was made with Commissioners Langer, Knowles & Knutsen voting Yes, Commissioner Wilson voting No and Commissioner Williams abstaining. Other Programs Discussed at Program Committee
Meeting: Brookside Research & Development
Preventing Falls in Older Adults through Communities of
Faith. Commissioners requested follow-up.
Snohomish County Music Project – Committee
reviewed a summary of research related to music
therapy and evidence supporting its use. The materials
did not prompt a change in funding recommendation
for the program.

Presentation from Center for Human Services & Edmonds Family Medicine Ms. Gomillion and Ms. Shimada presented a proposal for a PCP and Behavioral Health Integration Program which would utilize two full-time behavioral health therapists embedded in Edmonds Family Medicine to screen for depression, anxiety, and substance abuse (E:84:16). The 2017 Program Committee will do a further review of this request.

Verdant Community Wellness Center Update Ms. Waldin provided a summary of programming for November & December 2016 (E:85:16) and called out the Spanish Language Suicide Prevention, International Survivors of Suicide Loss Day, and upcoming events including the Veterans Claims Seminar and an info session on the benefits of yoga. Ms. Waldin noted that a modest fee will be charged for yoga because it is an 8-week commitment. Scholarships for district residents are available.

Marketing Report

Ms. Piplic reported on the Verdant Healthier Community Conference which will be held on Monday, February 27, 2017 at the Lynnwood Convention Center (E:86:16). Molina Healthcare has been added as a bronze level sponsor. The sponsorship funds are used to help cover the cost of the speakers' fees.

Superintendent's Report

Superintendent Zapora reported on several items:

- The search by Waldron for the next Superintendent was done with excellence. Congratulations to Dr. Robin Fenn on her appointment.
- 2. Thank you to the staff of Verdant for their exceptional work.
- 3. Thank you to all community partners who help to do the work of Verdant.

- Commissioner Knutsen will serve as board president in 2017 and will be meeting with Brad Berg of Foster Pepper & Ben Lindekugel of the Association of Washington Public Hospital Districts today.
- 5. Dr. Robin Fenn will be meeting with Superintendent Zapora on December 20, 21, 22, 2016 and will join him in meetings with the staff, Sarah Zabel of Swedish Edmonds, and Howard Thomas of Thomas & Associates Consulting.
- 6. Superintendent Zapora will provide a year-end summary to the board.
- 7. The recent board retreat went well and Ms. Margot Helphand was an excellent facilitator.
- 8. Superintendent Zapora & Mr. Kosovich will be meeting with Dave Gossett to understand the future of the Snohomish Health District, which is not part of Snohomish County government.
- 9. Superintendent Zapora's time with Verdant ends at 3 p.m. on December 31, 2016 and he gave thanks to the board.

Public Comments Dr. Robin Fenn also thanked the board and is looking forward to joining Verdant.

Monthly Highlights November 2016

Verdant received dividends payments of \$43,788 and an unrealized loss of \$397,027 on our investment portfolio in November and closed with an ending market value of \$36,751,512.

Annual program commitments total \$6,482,100 and \$5,471,463 for 2016 and 2017, respectively. \$1,217,900 remains available to spend in 2016, of which \$34,587 is earmarked as Superintendent Discretionary.

Additional income of \$115,561 and expenses of \$77,544 from the Kruger Clinic were incurred, netting to an additional operating income of \$38,017 in November.

December 2016 Program Summary

- Four applications were reviewed, all of which are returning applicants
- Presentation from Center for Human Services at today's board meeting on a Behavioral Health Integration Project

Program Applications Recommended for Funding

• Senior Services of Snohomish County – Care Coordination Program – a renewal request for a program that supports coordination between healthcare providers and community services for adults. Funding is used to support two care transition coaches who follow up with high-need patients. The program has consistently exceeded its goals for participation and tracks follow-up with primary care and access to other resources such as meals, transportation, mental health services, etc. Last year, the program received 301 client referrals, mostly from Swedish Edmonds Hospital and other medical providers.

When funding was renewed two years ago, Verdant's board expressed interest in seeing additional revenue from other sources for the program. Senior Services has not made progress in identifying additional funding—they believe there are opportunities through the HCA's Health Homes or Care Coordination Agency Models, but those models have not been fully developed yet.

The program committee is recommending fully funding the request at \$135,000, but just for one year as alternative funding models emerge.

Program Applications Not Recommended for Funding

Alpha Supported Living Services – Wellness Program for individuals with Disabilities: a renewal request
for a program that provides nursing and preventative health services for people with developmental
disabilities in South Snohomish County. The individuals receiving services typically have a developmental
disability and/or mental health diagnoses that require a high level of support in a group living setting. This
program was initially funded through a non-profit called Smithwright Services, which was absorbed by Alpha
Supported Living. Program funds are used to partially support 2.5 FTE nursing support services. Alpha
Supported has requested renewal and an increase in funding from \$65,000 per year to \$80,000 per year.

The program committee is not recommending funding the program at this time. The committee felt that providing nursing services for residents did connect closely enough with a Verdant funding priority.

Program Applications for Additional Discussion

 Northwest Parkinson's Foundation – South Snohomish County Programming: a renewal request for South Snohomish County Parkinson's Programs. Funds would be used for the Dance for PD programs as well as an educational program called PD University, which would be held at the Lynnwood Convention Center.
 Verdant previously provided a one-time grant to help start the Dance for Parkinson's Program in South Snohomish County. When funded, the intent was that funds would be provided on a one-time basis. The program has reached 350 people through 64 classes held since inception. The request is for \$20,000 per year for two years. Funds would primarily be used to start a new Edmonds-based Dance for PD group (\$8,000) and to sponsor the PD University conference (\$12,000).

The program committee did not reach a consensus recommendation so the request is coming forward to the full board for discussion.

Other Programs Discussed at Program Committee Meeting

 Brookside Research & Development / Preventing Falls in Older Adults through Communities of Faith (fiscal sponsor through Senior Services of Snohomish County): a program that used faith congregations and community organizations along with technology to screen and assess for fall risks among older adults, and then to connect individuals with the appropriate interventions. The renewal request seeks \$46,525 to add additional screening sites and provide additional interventions.

The program committee had several follow-up questions for the applicant, and would like to explore opportunities to target higher risk populations.

 Snohomish County Music Project: the committee reviewed a summary of research related to music therapy and evidence supporting its use. The materials did not prompt a change in funding recommendation for the program.

Program Presentation

• Center for Human Services - Edmonds Family Medicine: PCP and Behavioral Health Integration: a request to support two mental health clinicians from the Center for Human Services at Edmonds Family Medicine. The program is designed to integrate behavioral health and primary health care at a medical clinic. EFM patients would be screened for probability of behavioral health issues, and, when appropriate, provided with a "warm hand-off" to a behavioral health clinician. After referral, the patient will be screened more thoroughly and, if appropriate, participate in brief interventions (averaging 6 sessions). Center for Human Services is requesting \$190,999 per year for three years for the program.

Its mission is "empowering people to lead healthier lifes". EMF physicians have comprehensive training which allows them to diagnose and treat a wide range of medical problems.

Center for Human Services (CHS) is a community-based not-for-profit youth and family services agency that has been a resource for children, youth, adults and families since 1970. For the last few months, we have been piloting a SBIRT program, placing a therapist at EFM for a few hours one day a week, and it seems to have a lot of potential. Without funding, however, it will not continue past the end of 2016. Because we have already begun addressing such things as training with the medical staff, creating initial screening processes, gaining authorization to document in the EFM medical record, etc., this pilot has layed the groundwork for us to quickly hire staff and offer a comprehensive SBIRT Program for adults, youth, and children at EFM every day of the week.

How many years has the program been providing services?

Screening, Brief Intervention, and Referral to Treatment (SBIRT) is an evidence-based, comprehensive public health approach for delivering early intervention and treatment to people with or at risk for behavioral health problems. The program is designed to integrate behavioral health and primary health care at a medical clinic. Two clinicians from CHS would be located at the Edmonds Family Medicine clinic full time. EFM patients would be screened for probability of a behavioral health issues, and, when appropriate, provided with a "warm hand-off" to our behavioral health clinician. Without struggling with making appointments, navigating systems and schedules, identifying funding sources if they exist, or determining eligibility, all referrals would be immediately invited to engage in the program. After referral, the patient will be screened more throroughly and, if appropriate, participate in brief interventions (averaging 6 sessions). The structure and interventions will follow empirically supported brief intervention models, based on the nature of the presenting concern. Interventions provided would include patient education, Cognitive Behavioral Therapy, Solution Focused Brief Therapy, and Motivational Interviewing. A "treat to target" model will be used. In other, the clinician will focus on a specific problem and provide a direct intervention. If at any point from intake to the last session, it becomes evident that the patient needs on-going behavioral health treatment rather than a brief intervention, a referral will be made by the clinician. The goal would be to connect the patient with treatment or whatever other resources are needed and also facilitate the patient's engagement in these services.

The key to the program is the partnership between EFM staff and CHS clinicians. Both parties will openly share information relevant to the care of the patient. The CHS clinicians will chart their notes directly in the patient's EFM medical record. True integration of behavioral health with primary care occurs through the collaboration.

Regarding Verdant Health's priorities: The goal of SBIRT is to reduce or "prevent" related health consequences, disease, accidents, etc. Brief Intervention is characterized by a combination of counseling sessions and "education". The SBIRT model in general provides "Access to Healthcare Services", but the "Referral to Treatment" portion of SBIRT goes even further in giving patients access to behavioral health treatment.

G. What is the need for this program and who will you serve? Be sure to explain how the program serves residents of the Verdant Heath's <u>district</u> (limit 2500 characters). Also, please complete the Excel worksheet called participants served.

The unmet need is for early intervention for behavioral health problems which impact a person's general health. With an early intervention, beginning stages of behavioral health problems can be addressed long before the patient's symptoms become obviously severe. Chronic behavioral health problems are more costly than early intervention, and, early intervention can prevent costly medical conditions that are caused by or exacerbated by substance use or mental health problems. Primary care settings have become a gateway for many individuals with behavioral health and primary care needs. Integrating primary care and behavioral health, by embedding our services in a medical clinic, is our most promising way to reduce the negative impacts of behavior health problems. Verdant Health funding would allow us to reach more South Snohomish County residents with behavioral health problems.

EFM is physically located in Verdant Health's service area (Edmonds) and primarily serves South Snohomish County. Although EFM is a for-profit clinic, they treat a large number of low income individuals. Currently, 21% of EFM patients are on Medicare; 5 % are on Medicaid; 2 % have no insurance at all; and 40% have high-deductible health insurance plans. The majority of the patients with a high deductible cannot pay their services-applied-to-deductible. When we study the high deductible (and associated lack of payment) phenomenon, it turns out to be about 28% of the people with high deductible plans. All of this adds up to 56% of EFM patients are either low-income individuals or unable to afford non-emergent treatment because of their deductible.

EFM has approximately 95,000 patient visits per year. The primary languages spoken by patients are English, Russian, Spanish, and various Asian languages. The most frequently identified behavioral health issues identified by EFM physicians are depression, anxiety, and substance use disorders. Because EFM has a walk-in clinic that meets non-life threatening urgent care needs and is open every day of the year except Christmas and Thanksgiving day, they are a true hub for the whole community's medical needs.

While professionals recognize the value and positive outcomes of the SBIRT model, insurances (including Medicaid) are not yet willing to pay for these services by a behavioral health practitioner. This is apt to change in the years to come but, for now, we need Verdant funds to operate an integrated model of care.

H. What are your short and long-term goals, objectives, and anticipated outcomes of the program? How will you measure the impact of the program (limit 2500 characters)? Also, please complete the Excel outcome worksheet in addition to your written description.

The long term goal of the program is to provide and increase early access to behavioral health services, resulting in improved health (physical and behavioral) and wellbeing of the community. There is a growing body of evidence that supports SBIRT's effectiveness. In the future we should see reduced healthcare costs; decreased frequency and/or severity of behavioral health problems; reduced risk of trauma; and an increased percentage of patients who enter behavioral health treatment.

In the short term, our goal is to build the capacity to effectively provide SBIRT at the clinic. We will add a Substance Use screening tool to EFM's current pre-screening protocol, and we will train their staff on how to use these tools and when to refer to us for SBIRT services. Our objective is to ensure that each EFM staff member who will be actively involved in the SBIRT process is adequately trained and ensuring that SBIRT is utilized as the standard of care at EFM clinic outpatient offices. Therefore, on a systems level, our outcome is "increased access to behavioral health interventions".

On an individual patient level, our short term goals are to improve the problematic behavioral health symptoms the patients are experiencing, and, therefore, improve the overall health of the individual. We are measuring two specific outcomes:

- (1) The patient's depression and/or anxiety is improved, and/or the patient's substance abuse is decreased/eliminated through brief interventions;
- (2) Patients who need behavioral health treatment will be referred and begin treatment.

We will measure these by tracking beginning and ending scores on evidence-based screening instruments.

Integrating primary care/physical health with behavioral health in South Snohomiish County will result in long-lasting health improvements. Much work is to be done, however, to create a system that has the infrastructure needed to make integration possible so it will have long-term benefits for community members. The Affordable Care Act mandates that behavioral health and primary care are integrated by January 1, 2020. Due to this, we anticipate the state, behavioral health organizations, and even insurance carriers to establish some funding mechanisms for SBIRT services by that time.


